Club Board Elections

The Hotlanta Squares Annual Club meeting is scheduled for Monday June 22 at which time we will vote to fill 3 of the 8 board positions. Here is how it works . . .

The President, Vice President and President Emeritus each have a one year term and each year a new Vice President is elected. Then in musical chairs fashion the previous Vice President becomes the new President and the previous President moves to the President Emeritus role. The 5 other board positions are two year terms but elections are staggered so the Secretary, Web Master and Marketing Coordinator positions are elected on the even numbered years and the Treasurer and Events Coordinator positions are elected on the odd numbered years. 2015 being an odd numbered year means we

will be voting for Vice President, Treasurer and Events Coordinator at our June 22nd Annual Meeting.

If you would like to nominate a Hotlanta Square member (including yourself) for any of the open board positions please let a current board member know. An outline of the duties of each of these board positions follows.

- Assist the Events Coordinator with caller scheduling for special events and dances.

- Handle financial records, keeping them orderly, accurate and up-to-date;
- Provide annual tax reporting to the IRS and Georgia Department of Revenue,
- Ensure the Club's liability insurance premiums are paid so that coverage never lapses;
- Report to the Board of Directors and Club Members at the annual meeting regarding the Club's financial status;
- Provide monthly financial statements to the Board;
- Pay annual dues to any organization of which Hotlanta Squares is a member club, i.e. IAGSDC, MASDA, GSSDA;
